
Prospective Proposers and all concerned are hereby notified of the following changes and/or clarifications to the Request for Proposals document for the above-listed RFP.

1. The project is not dependent on Federal funding to proceed and Federal funding for the project is not anticipated.
2. Minimum requirements and forms used in Tab 2 will not count towards the 20-page limit.
3. For Tab 2 the reference form provided in the solicitation must be filled out for each reference. Additional information may be provided by the respondent, but additional pages will be counted towards the 20-page limit.
4. The existing buildings on the site will not be required to remain operational during construction and will be removed/demolished as part of the project.
5. The Table of Contents will not count toward the 20-page count limit.
6. Revit drawings converted to AutoCAD for submission is acceptable in lieu of specifically being prepared in AutoCAD 200 or later.
7. Exhibit A: Scope of Services – Engineering services (civil/stormwater, etc.) will be contracted as part of this scope through the selected firm.
8. Attachment A: Topographic and Boundary Survey – An updated survey with contour lines is attached.
