- To raise your hand to speak, click on ‘raise hand’ on the bottom of the ZOOM screen (you may have to move your mouse for the option to appear) and the Chairman will see that you have raised your hand.
- When the Chairman signals to unmute your line, then a popup will say “The host would like you to unmute your microphone.” You will need to click Unmute Now. You can then begin to talk.
